1. Have an overall (**State of TN “unweighted”**) GPA of 2.75 or higher (*attach a copy of high school transcript*)
2. Plan to pursue higher education at a two or four year school
3. Be a student who is involved in community service (*Complete the attached Community Service Form*)
4. Complete the enclosed application form
5. Write an essay on one of the topics listed on the application in the following format:
  - a. Two typed pages
  - b. 10 or 12 pitch font
  - c. Doubled spaced
6. Submit two letters of recommendation
7. Applicant’s name should be at the top of each page submitted.

**A selection will be made by May 2, 2016; therefore applications need to be submitted by April 15<sup>th</sup> 2016.** Students interested in being considered for the scholarship should return their completed application package to:
